Payment Terms: Payment terms are Net 30 days on approved credit and is calculated from date of invoice. We reserve the right to assess a finance charge Bank Wire Transfer, Visa, MasterCard, or American Express accepted for prepaid orders. No COD shipments.

Shipping: All freight is FOB from Hollister, CA.

Warm Weather Shipping: During warmer times of the year (e.g. when temperatures are expected to exceed 75°F in transit), cold packs may be needed to ensure the safe arrival of your order. Cold packs, an insulated shipper that holds 4 cases of product, and are provided to you at a cost of \$7.00 per shipper. At times when the temperature is expected to exceed 85°F in transit, it may be necessary to ship your order via 2-day, overnight or refrigerated service. We will seek approval prior to shipping via air or other premium service.

Backorders: No backorders will be generated. Please contact your Marich Sales Representative or Customer Care Representative to place a new order.

Returns: No returns without factory approval. All returns must be given a Return Authorization Number issued by Marich Confectionery. This number must be clearly marked on outer carton(s). Returns will be subject to a re-stocking charge of \$2.50 per case, minimum of \$5.00. Please call our Customer Care Dept. for any returns.

Damages in Transit: It is the customer's responsibility to count and note the condition of product at the time of delivery with the driver. In the event of damage or shortage, please record the damage/shortage on the delivery receipt/bill of lading and contact our Customer Care Dept. to report the damages within 10 days of receipt. Please do not discard any damaged product. Marich Confectionery will advise of final disposition of product as it may require inspection. Failure to comply with these instructions may prevent recovery from any loss.

Kosher Certification: Marich is certified by the KOF-K rabbinic supervision and produces a line of Kosher Dairy items. All certified kosher items are labeled with the applicable kosher symbol . Unless your facility is certified by KOF-K, you may not under any circumstance reproduce their symbols. A copy of the certification is available at your request.

Kosher Dairy: Milk and milk products from a kosher animal, including milk, butter, yogurt, and all hard and soft cream cheese. Dairy products must meet the following criteria in order to be certified kosher: They must come from a kosher animal and all ingredients must be kosher and free of meat derivatives.

Chocolate Shelf Life & Storage: Most Marich Chocolates have a 12–15 month shelf life from the date of production. Please contact your Marich Sales Director or Customer Care Representative for a detailed list.

Recommended Storage: Ideal Conditions 65°F and a relative humidity of 50%. Protect from Moisture and Avoid Prolonged Exposure to direct sunlight.

Minimum Temperature: 50°F / Maximum Temperature: 72°F.

Freezing is not recommended.
